



2012 Members' Day Trail Ride RSVP Form

GMHA has 5 fully marked Members Trail Loops, ranging from 5 to 15 miles long, available for use during our Members' Day Trail dates. Maps are available in the GMHA office for members only. If you plan to ride on one of our Members' Days, please complete this form and return to the GMHA office prior to arrival.

NOTE: Trails may be closed due to maintenance or conditions. Please check with the office prior to heading out on a trail. Please call ahead if there is inclement weather to see if Members' Day has been cancelled.

Guidelines for Members' Day participation...

- 1) Your signature on a GMHA waiver of liability release form must be on file.
- 2) Your horse's negative coggins dated within 12 months of the members day date needs to be on file. *
- 3) Your membership (and the memberships of anyone else in your party, including trainers) must be current. *
- 4) You must CHECK IN at the office upon arrival, and before unloading your horse. Regular office hours are Monday –Friday, 8:30 am – 4:30 pm. (NOTE: Using the grounds after office hours is at your own risk.)
- 5) Helmets are required for all riders on grounds/trails.

* Please call ahead to verify that your membership is current & your coggins is on file or bring a copy of your coggins to the office upon arrival.
